- The first Women's History Day was held in 1909. It commemorated the one-year anniversary of the garment workers' strikes when 15,000 women marched through lower Manhattan.
- The day became Women's History Week in 1978. An education task force in Sonoma County, California, kicked off Women's History Week on March 8, International Women's Day in 1978. They wanted to draw attention to the fact that women's history wasn't really included in K-12 school curriculum's at the time.
- In 1987, it became Women's History Month. Women's organizations, including the National Women's History Alliance, campaigned yearly to recognize Women's History Week. In March of 1987, activists were successful and Congress declared March Women's History Month.


