## **Facts About Breast Cancer**

- 1. In the US, 1 in 8 women will be diagnosed with breast cancer in their lifetime.
- 2. The most significant risk factors for breast cancer are being female and aging. About 95% of all breast cancers in the US occur in women 40 and older.
- 3. Women who get regularly screened for breast cancer have a 47% lower risk of dying from the disease compared to those who don't.
- 4. Breast cancer deaths have been declining since 1990 thanks to early detection, better screening, increased awareness, and new treatment options.
- 5. Breast cancer is the second leading cause of cancer death among women in the US and the first leading cause of cancer death among women globally.



- 6. In the US today, there are more than 3.5 million breast cancer survivors the largest group of all cancer survivors.
- 7. Every 2 minutes, a woman is diagnosed with breast cancer in the US.
- 8. A man's lifetime risk of breast cancer is about 1 in 1,000

# **DELINQUENT LETTERS**

Nationwide receives back boxes full of returned mail each time our Delinquent Letters go out to your borrowers during tax reporting season. There are several reasons this may happen:

- 1. Borrower mailing addresses are left blank or incomplete upon submission to Tax Tie.
- 2. Mailing addresses are entered the same as property addresses for non-owner occupied properties.
- 3. Mailing addresses are submitted as a range of house numbers.
- 4. Borrowers have moved and the lender neglected to notify us.
- 5. Loans have been paid off and a deletion was not requested.

When we receive these letters back in the mail, we typically contact the lender directly, in order to obtain the most current mailing information.

If you receive an e-mail from us regarding this, please respond with an update. Otherwise we will be unable to notify your borrowers, even though you have paid for this service.

In situations where the loan has paid off, we sometimes receive unnecessary calls from borrowers who no longer have loans with our lenders. And since we were never notified, we are at a loss to help them.

Here's what you can do to help us correctly notify your borrowers:

- Enter the correct borrower mailing addresses
- Notify us of any borrower mailing address changes
- Submit deletions for paid off loans in a timely manner
